COURSE OFFERINGS

LIFEGUARD CERTIFICATION COURSE AMERICAN RED CROSS – VALID 2 YEARS

Course Prerequisites:

- Must be 15yrs old by last day of class
- Must be able to successfully complete pre-requisite swim test
- Must complete all online learning requirements
- Must attend all in-person sessions and pass all written exams and in-water skills tests

Course Fees:

- Full Course = \$375 (includes CPR mask & whistle)
- Renewal/Crossover = \$175 (must bring equipment)

**Renewal/Crossover participants can be integrated into any full class. Must have a current certification from another recognized certifying agency.*

LIFEGUARD INSTRUCTOR CERTIFICATION COURSE AMERICAN RED CROSS – VALID 2 YEARS

Course Prerequisites:

- Must be at least 17yrs old by last day of class
- Must possess a current basic-level certification in Lifeguarding/First Aid/CPR/AED
- Complete all online learning requirements
- Must attend all in-person sessions and pass all written exams and in-water skills tests

Course Fees:

- Full Course = \$450
- Renewal/Crossover = \$400

**Renewal/Crossover participants can be integrated into any full class. Must have a current certification from another recognized certifying agency.*

PREREQUISITE SWIM TEST:

All lifeguard certification participants must be able to pass the following prerequisite swim test:

- 300 yard nonstop swim (must be done swimming freestyle, breaststroke, or a combination)
- Tread water for 2 minutes (legs only)
- Complete the following timed event in 1 minute, 40 seconds
 - Starting in the water, swim 20 yards
 - Surface dive (feet-first or head-first) to the bottom of the pool to retrieve a 10lb. Object
 - Without pushing off the bottom, return to the surface and swim 20 yards on your back, keeping your face at or above the surface
 - Exit the water without using a ladder or steps

ONLINE LEARNING REQUIREMENTS:

All courses are Blended Learning courses. Blended learning combines online learning with in-person skill sessions. The online learning portion of this course takes an average of 7 hours to complete and must be completed before the first in-person session of the course. Participants who fail to do so will not be allowed to participate in the in-person skills sessions and will not receive their certification.
