TAHL Player Guidelines and Policies

-Cost of TAHL season varies based on number of games per division

You will not be allowed on the ice if your league fee is not paid in full before first game.

**Injuries or missed games do not constitute a refund/pro-rate policy. TAHL players enter/sign up to play for an entire season, those players must pay in full. Instances will be handled on a case by case basis

** Having played or will play 6 or MORE games (Playoffs included) will be considered a FULL season and Full Payment will be required.

**Each player is personally responsible for wearing protective equipment during all games and warm-ups. Such equipment should include gloves, shin pads, shoulder pads, elbow pads, hip pads or padded hockey pants, protective cup, tendon pads plus all head protective equipment as required by USA Hockey rules.

Payments can be submitted online, over the phone, by mail, or in person.

TAHL Code of Conduct: By signing below, you agree to the following:

- I will not enter the ice until the Zamboni doors have been shut.
- No swearing or abusive language in the rink or at any SportsPlex function.
- No lashing out at any TAHL official (both on-ice and off-ice), or participant.
- Anyone who receives a penalty will skate directly to the penalty box. A captain may ask for a penalty explanation.
- Fighting will not be tolerated. Fighting will result in a suspension and possible hearing held by the TAHL discipline committee.
- Any player or team member who cannot abide by these rules or violates them will be subject to further disciplinary action.
